I am calling on Sligo County Council to put a structure in place similar to The Maritime Centre in Enniscrone, The Hawks Well Theatre, Sligo, and The Coleman Centre, Gurteen. The Ballymote Theatre and Film Company is a limited company and is debt free.

Funding is available to carry out a feasibility study to access the form and structure of a management team that should include representatives from the council, drama, tourism, the local community and any other potential users of the facility.

The Art Deco has the capability to be an interpretative centre highlighting the history of the region, the tourist attractions including the nearby megalithic tombs, Ballymote Castle, The Book of Ballymote, Carrowmore Megalithic site, Lissadell House, Glencar Waterfalls, Parkes Castle, Yeats Grave, all a short journey off the Wild Atlantic Drive.

I think that Sligo County Council is duty bound, as custodians of this property to ensure that this facility is managed in a transparent and accountable manner and that it achieves its full potential for the future enjoyment for the entire community."
