Sligo Borough Council consider that the current zoning of the subject lands should be amended having regard to (a) their location within an established business park, (b) the development of a portion of the lands already for business related purposes (c) their ownership by IDA Ireland since the early nineties (i.e. prior to the adoption of the current statutory Development Plan) and (d) the zoning of the subject lands for industrial purposes in the previous statutory development plan.

Following screening and consultation with prescribed environmental authorities, the planning authority has determined that the Proposed Variation is not likely to have significant effects on the environment.
