Section 1 Introduction and Background

1.1 Introduction

This is the Screening for Strategic Environmental Assessment (SEA) Report for the Sligo Local Economic and Community Plan 2023-2030 to be adopted ("the Plan").

SEA is the formal, systematic evaluation of the likely significant environmental effects of implementing a plan or programme, alteration to a plan or programme, etc., before a decision is made to adopt it. The SEA Directive¹ requires, inter alia, that SEA is undertaken for certain plans, programmes or alterations to these. Screening is the process for deciding whether a particular plan or programme, other than those for which SEA is mandatory, would be likely to have significant environmental effects, and would thus warrant SEA.

The purpose of this report is to inform: whether the Plan would, or would not, be likely to have significant environmental effects, taking into account relevant criteria set out under the SEA Directive and transposing Regulations²; and therefore would, or would not, necessitate the undertaking of SEA.

This report should be read in conjunction with the Plan and all other associated documents including the:

- Sligo County Development Plan, adopted in 2017;
- SEA Environmental Report for the Sligo County Development Plan, adopted in 2017;
- Appropriate Assessment (AA) Natura Impact Report for the Sligo County Development Plan, adopted in 2017;
- Variation No. 1 to the County Development Plan and associated environmental documents; and
- AA Screening Report for the Sligo Local Economic and Community Plan.

1.2 The Plan

The Sligo 2030 One Voice, One Vision Strategic Framework (the Sligo 2030 Plan), is Sligo's new Local Economic and Community Plan (LECP). The Plan fulfils the requirements of the Local Economic and Community Plan as set out in the Local Government Reform Act 2014. In combination with the existing planning framework, the Plan will guide the sustainable economic and community development of the County to 2030; however, it is not binding on Sligo County Council when undertaking its functions with respect to whether or not to grant development consent for a project. The development of LECPs is a requirement for all Local Authorities to assist in guiding the development of their respective counties.

The LECP includes goals and objectives related to economic elements such as actions to promote job creation and support existing businesses, and community elements including actions to support inclusion, access to services and addressing disadvantage amongst other areas.

The Plan's overall vision is as follows:

"The Vision is for a smart, sustainable, and socially inclusive Sligo; one that cherishes its vibrant communities, protects and celebrates its unique environment and rich culture, and is a champion of innovative growth and development."

While Sligo County Council will oversee its overall implementation, the Sligo 2030 Plan will be a shared Plan with vital roles to be played by the private sector, education providers and the wider community to ensure its success. This will include the private sector's contribution to job creation and innovation;

education and training providers' role in developing a skilled talent base; the community's participation in developing an inclusive and sustainable county, and the various state and semi-state bodies that will contribute to the overall wellbeing of Sligo through the provision of adequate services and supports for the community and business.

Sligo 2030 One Voice One Vision has been prepared by Sligo County Council in conjunction with the Sligo Strategic Policy Committee (SPC) for Planning, Community & Economic Development, Arts & Culture, the Local Community Development Committee (LCDC), and Sligo Economic Forum (SEF), and has included extensive and thorough consultation with the wider community, private sector, education providers, government agencies and other key stakeholders. The Regional Assembly (NWRA) has been Consulted to ensure consistency and alignment with the Regional Spatial and Economic Strategy and the Municipal Districts have been consulted for input and consistency in relation to the economic and community elements of the plan and with the existing County Development Plan.

As detailed in the introductory section of the Plan:

"Implementing the Sligo 2030 Plan will involve Sligo County Council helping to facilitate, promote, support and coordinate stakeholders in their activities in a way that is consistent with existing and emerging plans setting out public policy for sustainable development, including that relating to the economy, communities, infrastructure, land use tourism and environmental protection and environmental management.

This Plan is situated alongside this hierarchy of statutory documents that has been subject to environmental assessment/screening for environmental assessment, as appropriate, and forms the decision-making and consent-granting framework. The Plan does not provide consent, establish a framework for granting consent or contribute towards a framework for granting consent; the Plan is not binding on Sligo County Council when undertaking its functions with respect to whether or not to grant development consent for a project.

The Plan fully aligns with the provisions of the existing National Planning Framework, Ireland 2040, National Climate Action Plan 2023, Housing For All 2021, the Regional Spatial and Economic Strategy 2020-2032 and the current County Development Plan, all of which have been subject to legislative requirements relating to public consultation and environmental assessment/screening for environmental assessment. As such, the Plan is wholly subject to the requirements of the provisions set out in these documents (and any subsequent revisions to these documents), including provisions relating to sustainable development, environmental protection and environmental management that have been integrated into these documents, including through SEA and AA processes, and does not introduce any alterations or additions to those provisions.

In order to be realised, projects included in the Plan (in a similar way to other projects from any other sectors) will have to comply, as relevant, with various legislation, policies, plans and programmes (including requirements for lower-tier Appropriate Assessment, Environmental Impact Assessment and other licensing requirements as appropriate) that form the statutory decision-making and consent-granting framework, of which the Plan is not part and does not contribute towards".

1.3 Consultations

As part of the screening process, environmental authorities³ were notified that a submission or observation in relation to whether the Plan would, or would not, be likely to have significant effects on the environment may be made to the Council. One submission was received from the Environmental Protection Agency, which is responded to on Table 1.1 below.

Section 2 SEA Screening

2.1 Introduction

This section examines whether or not the Plan would be likely to have significant environmental effects (and thus would warrant the undertaking of SEA). This examination takes account of relevant criteria set out Annex II of the SEA Directive (see Section 2.4).

2.2 Screening for Appropriate Assessment

Appropriate Assessment (AA) is an impact assessment process concerning *Natura 2000,* or *European,* sites - these sites have been designated or proposed for designation by virtue of their ecological importance. The Habitats Directive⁴ and the Planning and Development Act 2000 (as amended) provide the requirement to screen for effects on European Sites. If the effects are deemed to be *significant, potentially significant or uncertain* then Stage 2 AA must be undertaken.

The Plan has been subject to a Screening for AA process in order to establish whether or not AA must be undertaken. The conclusion of the Screening for AA process is that the Plan will not give rise to any effects on the ecological integrity of any European Site, alone or in combination with any other plans, programmes, and projects etc.

2.3 Screening Analysis

The analysis of the Plan is undertaken with reference to the main interactions with Strategic Environmental Objectives⁵ (SEOs). SEOs are taken from the current Sligo County Development Plan SEA and are detailed in full at Table 2.1. The range of interactions identified with symbols are detailed on Table 2.2.

Using the SEO codes (Table 2.1) and interaction symbols (Table 2.2), Table 2.3 examines whether each relevant part of the Plan would be likely to have significant environmental effects (and thus would warrant the undertaking of SEA).

Table 2.3 is supplemented by Table 2.4 which provides details on:

- The likely significant effects of implementing the Plan, if unmitigated;
- Key mitigation measure(s) in force under the current Sligo County Development Plan that any projects under the Plan would be required to comply with; and
- Residual non-significant adverse effects arising from the Plan.

Effects encompass the full range of $effects^6$, including those arising cumulatively – such as those potentially arising as a result of interactions with other plans and programmes.

The examination of the Plan also takes into account relevant criteria set out under Annex II of the SEA Directive '*Criteria for determining the likely significance of effects referred to in Article 3(5)*' (see Section 2.4).
