	"I will ask for update of safety measures at the Holy Family N.S. Tubbercurry and if a pedestrian crossing can be installed between the Church and the School /Sofia/Convent on this road R294 Ballymote Road Tubbercurry in the interest of safety"
	Mr. Paddy Hughes informed the meeting that Safety measures have been submitted for funding under Low cost Accident scheme 2017 and Clar 2016. Funding has not been approved to date. With regard to the installation of a pedestrian crossing on the R294, this works cannot occur until a set down area is developed at the Holy Family N.S as the installation of a crossing would reduce parking along this section of the R294 thus effecting vehicle movements and pedestrian safety.

	The Head of Finance delivered her report and informed the Members that this issue will be kept under regular review.

	"To ask the Director of services to outline how the proposed future funding on N59 from Dromore West to the Mayo border will be spent "

	AND AGREED
	"To call on Sligo County Council to prepare a progress report on the N59"
	Mr. Paddy Hughes delivered his detailed report and added that it is unlikely that the funding will be received in 2017.

Councillor Queenan thanked Mr. Hughes and suggested reducing the speed limit in the short term and using solar speed indicators. There was a general conversation in relation to the quality of the land and Councillor Clarke stated that perhaps there could be discussion in relation to alternative realignment from Doonbeg to the Workhouse.

9. INDICATION OF HOW MANY MILES OF CLASS 2 AND 3 ROADS NEED UPGRADING	Proposed by Councillor J. Queenan Seconded by Councillor M. Gormley
	AND AGREED
	"To ask the Director of Service to indicate how many miles of class 2 and 3 roads need to be upgraded"
	Mr. Hughes gave his report which stated that a Pavement Surface Condition Index survey of our non national roads is being carried out at present. He acknowledged the views presented by the Members that much work is needed on the class 3 roads.
	Members suggested that our elected representatives in Daíl Éireann should all work together to seek resolution to this need and that once the survey has been completed, letters should also be written to Minister Ross and Minister Ring.
10. ADDITIONAL LIGHTING AT GURTEEN/CREAMERY ROAD, BALLYMOTE.	Proposed by Councillor K. Henry Seconded by Councillor D. Mulvey
	AND AGREED
	"To ask Sligo County Council if additional lighting can be installed out the Gurteen / Creamery Road, Ballymote. An additional one or two lights would greatly improve the current situation."
	Mr. Hughes informed the meeting that the Area Engineer will get an estimate to upgrade the public lighting at this location and the scheme can be considered under a future Schedule of Municipal Works for Ballymote/Tubbercurry Municipal District.
11. CALL ON MINISTER AND DEPARTMENT OF FORIGN AFFAIRS TO EXPLORE POSSIBILITY OF OPENING A PASSPORT OFFICE IN TUBBERCURRY.	Proposed by Councillor J. Lundy Seconded by Councillor P. Taylor
	AND AGREED
	"That this Council calls on the Minister and the Department of Foreign Affairs to again explore the possibility of opening a passport office in Tubbercurry to serve the people of the West and Northwest of Ireland"
	Councillor Lundy added that the office accommodation is in place and with the upcoming Brexit, more applications will be processed. All agreed with this motion.
	With the agreement of the Members, Councillor Mulvey's Motions were taken at this stage as he had to leave the meeting to attend a funeral.
13. REPAIR OF DAMAGED WALL ON ROAD L2101 AT	Proposed by Councillor D. Mulvey Seconded by Councillor P. Taylor

"To ask Sligo County Council to repair the old damaged wall on road L2101 at Ardcotton on the Coolaney to Collooney road as there are large loose stones falling out onto the road."

Mr. Hughes reported that the Area Engineer will arrange for a speed survey to be carried along this section of road to assess the problem before any determination of appropriate Traffic Calming measures can be made however, there is no funding available to date for this scheme.

	 "(A) That the council put measures in place on R294 at St Attracta's Community School to improve safety for those exiting from the carpark" "(B) To resolve flooding problem on R294 at Ballyara, Tubbercurry"
	Mr. Hughes delivered his report to the Members. It was noted that the maintenance of the channel is a matter for the householder.
17. DUMPING AND BURNING OF RUBBISH AT VACANT HOUSES IN CONNOLLY PARK, TUBBERCURRY.	Proposed by Councillor M. Gormley Seconded by Councillor K. Henry

	Mr. Kilfeather informed that meeting that The Housing Team will remove all waste and material dumped on the sites in the Council's ownership and the dumping and burning issues will be investigated by the Environment Section as soon as resources allow. Councillor Gormley thanked Mr. Kilfeather and acknowledged the work being done by the Environmental Services staff.

19. WALL ON BRIDGE ALONG ROAD NO. 513 IN CLOONACOOL.	Proposed by Councillor J. Lundy Seconded by Councillor P. Taylor AND AGREED "To ask if the wall on the bridge along Road No.513 in Cloonacool could be lowered in the interest of road safety, as cars exiting the Church cannot see traffic coming from the right (Coolaney road)" Mr. Hughes in his report stated that the lowering of this wall is not advised as this will not improve vision from this entrance due to the alignment of the existing road / bridge adding that it will be difficult to resolve.
21. UPGRADE SECTION OF ROAD FROM HEAPSTOWN TO KNOCKNACROSS, RIVERSTOWN.	Proposed by Councillor M. Baker Seconded by Councillor K. Henry AND AGREED "To ask Sligo County Council to upgrade the section of road from Heapstown to Knocknacross, Riverstown". Mr Hughes informed the Members that the Ballymote Area Engineer will survey the

	AND AGREED The correspondence received was noted. Councillor Lundy thanked Ms. Clarke, Director of Service for same and added that pressure must continue to keep this project moving forward.
24. AOB	Councillor Clarke raised the proposed relocation of Agricultural Laboratories to Kildare, stating that people will not want to bring animals on that journey and asked that Sligo County Council write to the Minister for Agriculture in relation to this. Councillor Gormley added that this should be brought to the attention of the Dáil Deputies and that it be raised at the next meeting of Sligo County Council.
	Councillor Clarke paid tribute to the two Jesus & Mary Secondary School students Matthew Blakeney and Mark McDermott who were runners up in the BT Young Scientist 2017 and suggested that a civic reception be held for them.
