**Who we are and why do we require your information?**

Sligo County Council seeks to promote the economic, social and cultural development of County Sligo and in doing so contribute significantly to improving the quality of life of the people of County Sligo. The Council also aims to link, liaise and collaborate with the “Sligo Diaspora”.

The delivery of high quality services, tailored to meet the needs of all our customers, remains one of Sligo County Council’s core objectives and is included in our Corporate Plan. This quality service includes not only the level and quality of service given to our customers, but also the quality of our decision-making processes, the efficiency and effectiveness of our corporate operations, standard of our facilities and our ability to adapt in an ever-changing environment.

In order to provide the most effective and targeted range of services to meet the needs of the citizens, communities and businesses of County Sligo we will be required to collect, process and use certain types of information about people and organisations. Depending on the service being sought or provided the information sought may include ‘personal data’ as defined by the Data Protection Acts and by the General Data Protection Regulation (GDPR) and may relate to current, past and future service users; past; current and prospective employees; suppliers; and members of the public who may engage in communications with our staff. In addition, staff may be required, from time to time, to collect, process and use certain types of personal data to comply with regulatory or legislative requirements.

**Why do we have a privacy statement?**

Sligo County Council has created this privacy statement in order to demonstrate our firm commitment to privacy and to assure you that in all your dealings with Sligo County Council that we will ensure the security of the data you provide to us.

Sligo County Council creates, collects and processes a significant amount of personal data in various multiple formats on a daily basis. Sligo County Council’s commitment to you is that the personal data you may be required to supply to us is;

- Obtained lawfully, fairly and in a transparent manner
- Obtained for only specified, explicit and legitimate purposes
- Adequate, relevant and limited to what is necessary for purpose for which it was obtained
- Recorded, stored accurately and securely and where necessary kept up to date
- Kept only for as long as is necessary for the purposes for which it was obtained.
- Kept in a form which permits identification of the data subject
- Processed only in a manner that ensures the appropriate security of the personal data including protection against unauthorised or unlawful processing.

## **Data Protection Policy**

Sligo County Council has a detailed Data Protection Policy which goes into more detail on how we as a public body are committed to ensuring the security of any personal data you provide to us.

### **What personal data do we need?**

The types of personal data you may be asked to supply can be categorised as follows,

- Contact details to allow for efficient communication
- Details of your personal circumstances which you are required by law to supply as part of your application for a service offered by Sligo County Council
- Your own financial details which you are required by law to supply as part of your application for a service offered by Sligo County Council

Depending on the service being accessed, all applicants for Community & Economic Development Supports may be required to provide information on the following categories of data (where they are applicable);

- Name, Address & Phone Number
- Email Address
- Identification Number / Reference
- Income Details
- Employment Details
- Family Composition
- Bank Account Details
- Revenue Details
- Date of Birth
- Religion
- Business Details
- Membership or position held on committees
- Details of Membership of PPN

### ***Sharing Information***

The Council may share your information internally (within the Council) in accordance with statutory obligations. In addition, the Council may share your information with third parties in accordance with statutory and regulatory obligations.

The staff of Community & Enterprise may share your information with the following bodies:

- Partner Deliveries
- Funding Agency
- PPN Secretariat

### **Contact Details**

In order to communicate with you, contact details will be requested of you. You do not have to provide all contact details but providing more, such as email, phone, address, makes it easier to communicate.

### **Details of Personal Circumstances**

If you wish to apply for a particular service from the local authority you will be asked for a varying amount of personal details specific to you and your family, in order to support your application. Sligo County Council will set out the information we require in a series of separate and distinct application forms relevant to each service.

### **Financial Details**

If you wish to apply for a particular service from the local authority you may be asked for a varying amount of personal financial details specific to you and your family, in order to support your application. Sligo County Council will set out the information we require in a series of separate and distinct application forms relevant to each service. As is the case with the other personal data outlined above the specific service/section of Sligo County Council will address the necessity for the financial details as part of their specific privacy notice.

### **Your Data Protection Rights**

You have the right to request access to personal data held about you, obtain confirmation as to whether data concerning you exists, be informed of the content and source of data and check its accuracy. In addition, if the data held by us is found to be inaccurate you have the right to change, remove, block, or object to the use of, personal data held by Sligo County Council. In certain circumstances blocking access to data may delay or remove access to a service where the data is required by law or for essential purposes related to delivery of a service to you. Please note that to help protect your privacy, we take steps to verify your identity before granting access to personal data. To exercise these rights you should take the following steps:
