- 2. Evidence of current registration with the PRTB (in the previous 4 years)
- 3. Evidence of current paid buildings insurance policy/schedule (NOT A RENEWAL).
- 4. Mortgage statement dated within the last 12 months.
- 5. Evidence of payment of LPT Payment cannot be made by any other party other than the owner.

Statement on Ownership
