

**Decision of the Planning Authority**  
regarding the need for  
Strategic Environmental Assessment of the proposed  
**ENNISCRONE LOCAL AREA PLAN 2014-2020**

Sligo County Council has prepared a Draft Local Area Plan for Enniscrone for the period 2014-2020.

Having assessed the potential environmental effects of implementing the proposed plan, and having consulted with the prescribed environmental authorities, the Planning Authority has determined that **the Draft Enniscrone Local Area Plan 2014-2020 is not likely to have significant effects on the environment. Therefore, full Strategic Environmental Assessment (SEA) is not required.**

The SEA screening process and the reasons for this decision are summarised in the following pages.

## **1. Proposed Enniscrone LAP 2014-2020 - background**

Enniscrone Local Area Plan 2004-2013 was adopted by Sligo County Council on the 1st March 2004. The Sligo County Development Plan 2011-2017 (CDP) now specifies that the Enniscrone Local Area Plan is to be reviewed by 2014.

This LAP is prepared in accordance with the procedure set out in Sections 18–20 of the Planning and Development Acts 2000 (as amended).

The CDP earmarks Enniscrone as a Key Support Town, in order to build on its strengths and existing scale of development. As recommended in the CDP, the strategy for Enniscrone is to consolidate the town through the provision of an appropriate range of services including social infrastructure, retail, tourism, commercial and enterprise facilities to enable it to perform its role in an appropriate manner.

## **2. SEA – legal requirements**

The Strategic Environmental Assessment (SEA) Directive (2001/42/EC) applies to plans and programmes for which formal preparatory action started on or after the 21st July 2004. The component of the SEA Directive relating to land use planning was transposed into Irish law in the form of the Planning and Development (SEA) Regulations 2004 (S.I. 436/04), which was amended by the Planning and Development (Strategic Environmental Assessment) (Amendment) Regulations 2011, (S.I. No. 201 of 2011).

In accordance with Article 14A of the SEA Regulations, prior to commencing the procedure for preparing the local area plan, it was necessary to “screen” the proposed plan, or determine whether the implementation of the plan would have significant effects on the environment.

## **3. SEA screening**

The proposed plan was screened for potential environmental effects in accordance with the criteria set out in Schedule 2A of the SEA Regulations. The conclusion of the screening exercise was as follows:

*The Draft Enniscrone LAP 2014-2020 will be prepared in the context of the existing CDP 2011-2017, which sets out a strategy for the proper planning and sustainable development of the County and has already been assessed under the SEA completed as part of the CDP process.*

*The LAP will be consistent with the CDP. The CDP provisions (including the SEA mitigation measures) will apply to the LAP area.*

*The LAP will be focused on the consolidation of the town and the protection of Natura 2000 and other designated areas within the Plan area.*

*When compared to the existing Enniscrone LAP 2004-2013, the proposed LAP will involve a significant reduction in the extent of overall area of greenfield land available for development during the plan period, particularly in relation to residential development. It will also establish a Buffer Zone in order to facilitate the above-mentioned urban consolidation and to offer additional protection to designated natural heritage areas.*

*Having described the characteristics and assessed the expected effects of implementing the Local Area Plan for Enniscrone, and having regard to the characteristics of the area likely to be affected, it appears that the proposed LAP, if implemented, would have negligible effects on the environment.*

*On the basis of the above assessment based on the criteria set out in Schedule 2A of the SEA Regulations, it is the opinion of the Planning Authority, at this stage of the process, that the proposed Enniscrone LAP is not likely to have significant effects on the environment.*

*Accordingly, a full Strategic Environmental Assessment is not required.*

#### **4. Consultation with prescribed environmental authorities**

In accordance with the requirements of the SEA Regulations, the Planning Authority consulted with the prescribed environmental authorities – the Minister for Environment, Communities and Local Government, the Minister for Communications, Energy and Natural Resources, the Department of Agriculture, Fisheries and Food, the Environmental Protection Agency, the Planning Authorities of counties Mayo, Leitrim and Roscommon and to Ballina Town Council.

Formal notification, accompanied by the Screening Report, was issued to the prescribed environmental authorities in December 2013, giving them an opportunity to comment on the likely environmental effects of implementing the proposed Enniscrone LAP. The deadline for returning comments was January 2014.

The following agencies responded with comments: Roscommon County Council, Leitrim County Council, the Department of Communications, Energy and Natural Resources, the Department of Agriculture, Food and the Marine and the Environmental Protection Agency.

Their recommendations and suggestions made by from prescribed environmental authorities have been adequately incorporated into the Draft LAP. It should be noted that, as outlined in the Enniscrone LAP, the existing provisions of the County Development Plan will continue to apply to the plan area.

The lack of a response from some prescribed environmental authorities cannot be construed as an implicit agreement with the Planning Authority's conclusion regarding the level of impact of the proposed LAP on the environment. However, in the absence of recommendations from such authorities, the Planning Authority has no reason to alter the Draft LAP or the SEA Screening Report.

## **5. Decision**

Based on the conclusion of the Screening Report, the response of the prescribed environmental authorities and the above considerations, it is the decision of the Planning Authority that full SEA is not required for the Draft Enniscrone Local Area Plan, which is unlikely to give rise to any environmental effects, significant or otherwise.
