COMPULSORY PURCHASE ORDER UNDER SECTION 76 OF AND THE THIRD SCHEDULE TO THE HOUSING ACT 1966 AS EXTENDED BY SECTION 10 OF THE LOCAL GOVERNMENT (NO. 2) ACT 1960 (AS SUBSTITUTED BY SECTION 86 OF THE HOUSING ACT 1966) AND AMENDED AND EXTENDED BY SECTION 6 AND THE SECOND SCHEDULE OF THE ROADS ACT 1993 AND AMENDED BY THE PLANNING AND DEVELOPMENT ACTS 2000 TO 2018 AND UNDER SECTION 213 OF THE PLANNING AND DEVELOPMENT ACT 2000 (AS AMENDED), THE HOUSING ACTS 1966 TO 2017, THE LOCAL GOVERNMENT ACTS 1925 TO 2016 AND THE ROADS ACTS 1993 (AS AMENDED).

WHEREAS in pursuance of the provisions of Section 76 of and the Third Schedule to the Housing Act 1966 as extended by Section 10 of the Local Government (No. 2) Act 1960 (as substituted by Section 86 of the Housing Act 1966 as amended) and as amended and extended by Section 6 and the Second Schedule of the Roads Acts 1993 and the Planning and Development Acts 2000 to 2018 and in particular by section 222 of the Planning and Development Act, 2000 and in exercise of the powers conferred on it by the above mentioned legislation and in particular section 213 of the Planning and Development Act, 2000 as amended, **SLIGO COUNTY COUNCIL** (hereinafter referred to as "the Local Authority") acting on its own behalf, has decided to effect the acquisition of the lands to which this Order relates.

NOW THEREFORE IT IS HEREBY ORDERED THAT

1. Subject to the provisions of this Order, the Local Authority is hereby authorised to acquire compulsorily, for the purpose of providing a road development consisting of the construction of the N16 Lugatover (Drumkilsellagh to Lugnagall) Road Development and all ancillary works associated therewith, the land described in the Schedule hereto which land is shown on the maps **Deposit Map No. SCC/CPO/N16 (Sheet 1 of 2) through to Deposit Map No. SCC/CPO/N16 (Sheet 2 of 2) inclusive** (hereinafter referred to as "the deposited maps") marked

and sealed with the seal of the Local Authority and deposited at the following locations;

- **Sligo County Council, County Hall, Riverside, Sligo, F91 Y763;**

- **TII National Roads Project Office, Sligo County Council, Business Centre, Market Yard, Sligo, F91 WV7R;**

- (b) to temporarily acquire lands in the Schedule Part 2.
- (c) to extinguish the public and private rights of way described in the Schedule Part 3 hereto by order made after the acquisition of the land, where the said rights of way are over the land so acquired or any part thereof, or over land adjacent to or associated with the land so acquired or any part thereof.
2. The land described in the Schedule Part 1 and Schedule Part 2 hereto and coloured grey and outlined in red on the said deposited maps is land other than land consisting of a house or houses unfit for human habitation and not capable of being rendered fit for human habitation at reasonable expense.
3. Subject to any necessary adaptations, the provisions of:
- (a). The Lands Clauses Acts (except Sections 127 to 132 of the Lands Clauses Consolidation Act 1845, and Article 20 of the Second Schedule to the Housing of the Working Classes Act 1890), and
- (b). The Acquisition of Land (Assessment of Compensation) Act 1919 as amended by the Acquisition of Land (Reference Committee) Act 1925, the Property Values (Arbitration and Appeals) Act 1960, and the Local Government (Planning and Development) Acts 1963 (as applied by section 265(3) of the Planning and Development Act 2000) and the Planning and Development Acts 2000 to 2018
- as modified by the Third Schedule to the Housing Act, 1966, are hereby incorporated in this order and the provisions of those Acts shall apply accordingly.
4. This order may be cited as: -
