DOCUMENTATION REQUIRED FOR ANNUAL PARKING PERMIT

When applying for an Annual Parking Permit you must submit the following documents with your application:

- 1. Completed Application Form
- 2. Valid Driving Licence of person applying for Annual Permit.
- 3. Vehicle Licensing Certificate for the vehicle for which the permit will be issued.
- 4. Proof that the vehicle is currently taxed.
- Current Certificate of Motor Insurance.

Applications are only accepted when fully completed and accompanied by all required documentation above. Documentation may be presented in person at the Finance Cash Desk, Sligo County Council, Riverside, Sligo or emailed to parkingpermits@sligococo.ie Please ensure all emailed documents are clearly legible.

ANNUAL PERMIT CONDITIONS

An Annual Parking Permit <u>must be displayed at all times</u> during pay and display parking hours, failure to clearly display the permit may result in you receiving parking fines. An Annual Parking Permit does not guarantee the holder a public parking space.

An Annual Parking Permit does not authorise parking in a prohibited manner or place. An Annual Parking Permit is only valid for the Car Park Schedule indicated on it.

Replacement of Permit due to loss, change of vehicle etc is subject to a fee of €10.00. If you have changed your vehicle during the life of the permit a new application must be completed, and the required documentation submitted.
